

## CO-OPP's Has a New Website Platform

Unless you have been off the island, you have heard...CO-OPP has moved their website to a new platform using ClubExpress. Under the leadership of CO-OPP's Website Committee Chair, Veronica Gayotin, the committee worked with NIGP and ClubExpress for several months to transition to this new site effective April 17th.

All active, and expired, members will find that their membership information was transferred from the previous site to the new site. Members received a Welcome email from ClubExpress encouraging members to log-in to the new site to review and update their personal information.

CO-OPP established its previous site in 2008; it served the chapter well for the past 14 years, but the site provider will be ceasing their operation in September. At the end of last year, the Board of Trustees elected to move forward with an opportunity being provided by NIGP to their affiliate chapters for a free website solution

With the support of NIGP's government partner, Sourcewell, NIGP is able to offer a website solution, free of charge, to their affiliate chapters through ClubExpress. NIGP elected to offer this service to its chapter to develop stronger relationships with them. NIGP recognized that this opportunity would reduce the burden and cost for the chapters in maintaining their local websites.

NIGP's solution meets/exceeds members' needs by offering all core functionality, allows for NIGP to syndicate content, and provides better customer service/support/training.


• Construction Junction: Changes made during COVID with construction and how they were received. Also, lessons learned from a Construction student on doing site visits virtually.


